Pursuant to 28 U.S.C. §§ 1441(a) and (c), and 1446, Defendants Governor Gary R. Herbert and Joseph K. Miner ("Defendants"), by and through counsel, give NOTICE OF REMOVAL of the civil action pending in the Third Judicial District in and for Salt Lake County, State of Utah, entitled *Epilepsy Association of Utah et al., v. Gary R. Herbert et al.*, Case No. 180909139, to this Court. The grounds for removal are as follows:

1. This action was commenced by the filing of a Complaint (the "Initial Complaint") on December 5, 2018, in the Third Judicial District Court in and for Salt Lake County, State of Utah. On that same date, Defendants received a copy of the Original Complaint.

2. The Initial Complaint was not removable because it raised claims arising only under Utah law, specifically Article VI, Section 1, and Article 1, Section 4 of the Utah Constitution

3. On May 3, 2019, Plaintiffs filed an Amended Complaint in state court.

4. In the Amended Complaint, Plaintiffs included a new cause of action that raised, for the first time in this action, claims arising under federal law. Accordingly, this Court has original jurisdiction of this action under 28 U.S.C. § 1331, and this action may be removed to this Court under 28 U.S.C. §§ 1441 and 1446.

5. Removal of this action is timely. The Defendant first received the Plaintiffs' First Amended Complaint on May 3, 2019. *See* 28 U.S.C. § 1446(b)(3)

6. As of the date of this removal, both Defendants have consented to removal.

7. Pursuant to 28 U.S.C. § 1446(a), copies of all process and pleadings that have been received by Defendant and are attached hereto as Exhibit A.

WHEREFORE, Defendants submit this Notice that the above-entitled matter is hereby removed from the Third Judicial District Court in and for Salt Lake County, State of Utah, in accordance with the provisions of 28 U.S.C. § 1446.
